

The CPI 400 is suitable for dry natural gas, propane, butane, air and inert gases. Suitable for up to 0.1% by volume, dry  $H_2S$  when used with stainless steel adapter.

A "dry" gas has a dew point lower than +15 °F and its relative humidity is less than 60 %.






